OFFICIAL MINUTES OF THE SPECIAL SCHOOL BOARD MEETING TUESDAY JUNE 3, 2021

Board Chair Steve Nelson called the meeting to order at 6:07 p.m.

NEW BUSINESS:

Consider Pre-Purchase of Material for Elementary Seismic Project:

Dr. Long spoke about the significant inflation taking place in material cost and requested approval from the board on an early work amendment along with approval for pre-purchasing materials for the Elementary Seismic Project. He shared that the approval would protect the contingency and have the availability of materials on hand to proceed with the project. Dr. Long stated that the total amount needed to cover the asbestos abatement, roofing tear off, insulation and metal siding would be \$676,645.39.

Mrs. Aiken shared that the funds were available in the interim until she was able to get the funds reimbursed through the grant.

Mr. Murphy made a motion to approve pre-purchasing material for the Elementary Seismic Project and executing an Early Work Amendment in the amount not to exceed \$676,645.39. Mr. Carlton seconded. 3 ayes, 0 opposed. (Mrs. Pitts lost connection)
